## MUNICIPALITY OF LOUISE CLOSE PUBLIC ROAD BY-LAW NO. 2025-08

Being a By-law of the Municipality of Louise to close a municipal road and transfer of land.

WHEREAS The Municipal Act provides, in part, as follows:

290(1) 'Subject to subsection (2), a municipality may close a municipal road by

- a) Passing a By-law closing the road; and
- b) [repealed] S.M. 2018, c. 29, s. 26;
- c) Registering the approved By-law and a plan at the appropriate Land Titles office.

AND WHEREAS the following described municipal road is no longer required for public purposes and it is necessary and desirable and in the public interest that the road be closed.

NOW THEREFORE, the Council of the Municipality of Louise enacts as follows

- 1. That all that portion of the municipal road shown on a plan prepared by Jesse Paul Simon Carels, Manitoba Land Surveyor, certified by him on 9<sup>th</sup> of June 2025 and on deposit with the Morden Land Titles Office as Deposit No 0565/2025 MLTO (hereinafter referred to as Parcel 'A') be and the same is hereby closed.
- 2. That, subject to paragraph 3 herein, all that portion of Parcel 'A', being part of Cameron Avenue, Plan 180 (Deposit 0565/2025) MLTO in NE ½ 24-2-12 WPM be so closed, EXCEPTING thereout all mines and minerals and other matters as reserved in the Crown Lands Act, shall be transferred to the registered owner of the adjacent land described as:

  LOT 5, PLAN 40356
  and consolidated with their title (Title 1862833 / MORDEN).
- 3. That the proper officers of the Municipality are hereby authorized and directed to do all acts and execute all documents required for the purpose of implementing the said closing and transfer.
