

MUNICIPALITY OF LOUISE

By-law No.2023-04 as amended

Being a By-law of the Municipality of Louise to authorize the expenditure and borrowing of money for the construction of a replacement swimming pool in the Local Urban District (LUD) of Pilot Mound as a Local Improvement.

Whereas Section 311 of *The Municipal Act*, S.M. 1996, C.58, provides in part as follows:

If approved by by-law, a municipality may undertake, as a local improvement for the benefit of all or part of the municipality,

- (a) the acquisition, development, upgrading or replacement of one or more of the following:
 - (i) sewage collection and treatment facilities;
 - (ii) water supply, treatment and distribution facilities;
 - (iii) waste management facilities;
 - (iv) highways;
 - (v) drainage systems; or
- (b) any other project the cost of which includes a capital component.

And Whereas subsection 320(1) of *The Municipal Act* provides as follows:

Subject to subsection (2) to (6) and subsection 321(4), a Council may by by-law

- (a) approve the local improvement or special service as set out in the plan or proposal;
and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

And Whereas Section 172 of *The Municipal Act* provides in part as follows:

In this Division,

"Borrowing" means the borrowing of money, and includes

- (b) borrowing to pay for a local improvement under Division 4 (Local Improvements and Special Services) of Part 10,
- (e) issuing debentures.

And Whereas, the Council of the Municipality of Louise has prepared Local Improvement Plan No. 2-2025 providing for the spending, borrowing authority and imposition of taxes for the reconstruction of a new swimming pool as a local improvement pursuant to Part 10 of *The Municipal Act*;

And Whereas, in order to complete such undertaking, it will be necessary for the Municipality of Louise to borrow the sum of \$1,500,000 as hereinafter provided, which is the amount of the debt intended to be created by this by-law;

And Whereas the consecutive annual amounts, including principal and interest, required to be raised each year for 15 years, as hereinafter provided, for paying the principal and interest under this by-law are the amounts set out in Schedule 'A' hereto;

And Whereas the requirements are prescribed in Sections 318, 319 and 320 of *The Municipal Act* have been complied with;

And Whereas the amount of the existing borrowing debt of the Municipality of Louise is \$251,135.88, of which no portion of the principal or of the interest thereon is in arrears;

Now therefore the Council of the Municipality of Louise in regular session assembled, enacts as follows:

1. That pursuant to subsection 320(1) of *The Municipal Act*, the Municipality of Louise adopt Local Improvement Plan No.2-2025 attached hereto as Schedule 'B'.
2. That the Municipality of Louise may expend \$3,265,919.67 for the purpose of construction of a replacement swimming pool in the LUD of Pilot Mound as a local improvement.
3. That for the aforesaid project, the said municipality may borrow one and a half million dollars (\$1,500,000), such borrowing shall be issued by the Municipality of Louise in the Province of Manitoba, and shall be payable at the Westoba Credit Union in Pilot Mound, and shall be dated the 31st day of December, A.D. 2024.
4. That the said borrowing shall bear interest at a rate estimated for the time being at 8% per annum, and subject in any event to the authorization of The Municipal Board at the time of sale, and shall mature in accordance with the maturities set out in Schedule 'A' hereto on the 31st day of December in each of the years 2025 to 2039, both inclusive.
5. That the issuance of borrowings shall be signed by the Reeve, or by some other person authorized by By-law to sign same, and by the Chief Administrative Officer of the Municipality of Louise and there shall be affixed thereto the corporate seal of the said municipality.
6. That during the currency of the said borrowing; namely, in each of the years 2025 to 2039, both inclusive, there shall be raised annually by a special rate on all rateable property described in Schedule 'C' hereto, an amount sufficient to provide for *part of* the principal and interest requirements hereunder.
7. That pursuant to subsection 174(3)(d) of *The Municipal Act*, pending the issue of the borrowing, the Council of the Municipality of Louise may agree with a bank or person or borrow from the general funds of the municipality for temporary advances from time to time to meet expenditures incurred for the purpose aforesaid, and the total of such advances shall not exceed one and a half million dollars (\$1,500,000).

8. That, at any time prior to or within (30) days following completion of the work, any ratepayer of the area affected by the local improvement as described in Schedule 'C' hereto may commute and pay in one principal sum that part of his/her share of the debt herein authorized in respect of the per parcel rate(s) provided herein to the said Chief Administrative Officer of the Municipality of Louise and thereafter no per parcel rate(s) shall be levied against his/her said lands in respect of the borrowing to be authorized herein.

SCHEDULE B

REGARDING LOCAL IMPROVEMENT PLAN 2-2025, BY LAW 2023-04 AS AMENDED
FOR THE CONSTRUCTION OF AN AQUATIC CENTRE

Description of the proposed local improvement – The Municipality of Louise is proposing to build a new aquatic centre located within the LUD of Pilot Mound. The location for a new facility is on the same parcel as the previous one based on infrastructure and utility services. The new facility includes improvements such as change and mechanical buildings, beach entry, lap area, 3 slides and a 4,746 sq ft pool.

Local Improvement district – The district under this proposal will be all Residential (Class 10) properties with dwelling units within the boundaries of the Municipality of Louise in addition to (as per Municipal Board Order E24-067 dated 22 July 2024) all vacant Residential (Class 10) lots, Residential 2 (Class 20), Farm properties (Class 30), Institutional properties (Class 40) and Commercial/Other properties (Class 60) and Designated Recreational Property (Class 70). Parcels designated as ‘school tax exempt’ are included in the Local Improvement district. Parcels designated as ‘exempt’ are not included in the Local Improvement district.

Potential tax payers under the Local Improvement Plan – Potential tax payers will be all Residential (Class 10), Residential (Class 20), Farm properties (Class 30), Institutional properties (Class 40), Commercial/Other properties (Class 60), Designated Recreational property (Class 70) and vacant residential lots within the Municipality of Louise.

Note – this ‘borrowing’ value will be reduced as fundraising and successful grant approval is obtained.

How was the levy distribution determined ?

Council identified that the majority of property owners live within the boundaries of the Municipality of Louise and therefore are eligible to make payments for this local improvement based on their dwelling unit. The other classifications identified by the Municipal Board Order are extra to dwelling units so the additional financial burden related to these parcels was calculated accordingly. Of the \$1,500,000 borrowing, Council chose to allocate \$1,250,000 to dwelling units and \$250,000 to other parcels.

Method and rate of calculating the Local Improvement tax – The method of taxation to be used to calculate the Local Improvement Tax will be an amount per parcel of land (as per the assessment roll list). The per parcel rate will be based on

1. the number of residential dwelling units on each parcel upto 3 dwelling units and for a parcel with 3 or more dwelling units a per parcel rate
2. a per parcel rate for the residual lots

There are 804 Class 10 residential parcels with 1 or 2 dwelling units and 13 Class 10 residential parcels with 3 or more dwelling units. There are 157 Class 10 residential vacant parcels, 2 Class 20 residential parcel, 1,453 Class 30 farm property parcels with no dwelling unit, 6 Class 40 institutional parcels, 125 Class 60 Other/Commercial parcels and 1 Class 70 Designated Recreational property; a total of 2,561 parcels

Taxation methods

\$1,250,000 is to be paid by Class 10 residential parcels with dwelling units

\$250,000 is to be paid by the residual parcels

Per parcel – 817 dwelling unit parcels, based on the borrowing calculation of \$1,250,000

- a) Cash option (pre-pay/lump sum) - \$1,529.99 per residential dwelling unit or dwelling unit parcel OR
- b) Finance option \$178.75 per parcel levied annually for 15 years. The amount will be levied on property tax bills starting in 2025.

Per parcel – 1744 residual parcels based on borrowing calculation of \$250,000

- c) Cash option (pre-pay lump sum) - \$143.35 per parcel OR
- d) Finance option \$16.75 per parcel levied annually for 15 years. The amount will be levied on property tax bills starting in 2025.

Pursuant to Section 325 of the Municipal Act, potential tax payers will be permitted to pre-pay their portion of the Local Improvement tax at the completion of the project by a date set by Council.

Funding of maintenance of proposed Local Improvement – annual maintenance costs associated with the Local Improvement Plan herein will be covered under operating revenues and expenses financed through the Pool budget and the annual Financial Plan.

Fundraising – The Pool Events & Corporate Fundraising Committees and Council will continue with fundraising efforts and explore all grant opportunities to further reduce the final amount to be borrowed.

Explanation of process – Council held public hearings and hosted a Municipal Board hearing on 19 January 2024. The Municipal Board Order from that hearing dated 22 July, received on 25 July 2024 directed –

THAT the Municipality of Louise draft proposed changes to By law 2023-04 by adding the following properties to the Local Improvement Area to be taxed under this By law: Residential 2 (Class 20), Farm properties (Class 30), Institutional properties Class 40), Commercial/Other properties (Class 60) and vacant residential lots within the Municipality and,

The Board will reconvene the hearing on a date to be determined to give all interested parties an opportunity to be heard.

It is required by legislation to publish a public notice for all affected taxpayers, hold a public hearing and pass a By law after receiving Municipal Board approval with the above information based on the requirement to borrow \$1,500,000 to finance the project. Once the project is complete and successful grants, donations along with public and corporate fundraising is known, an amending By law is passed which will identify the value of the debenture/borrowing needed. The ‘taxation method’ values will be adjusted accordingly and the public will be advised of the ‘cash’ option or the ‘finance’ option. Please note, this occurs when the project is complete.
